#### QUORUM

It was noted that sufficient people were present to meet the quorum requirements for a general meeting under the proposed constitution of the group.

#### SETTING OF ACCOUNTING YEAR END

It was proposed and agreed that the accounting year end should be September 30<sup>th</sup>.

#### APPROVAL OF ACCOUNTS TO SEPTEMBER 30<sup>TH</sup> 2014

It was proposed and agreed that the accounts for the period ending 30<sup>th</sup> September 2014 be approved with the proviso that if either of the outstanding receipts should prove to be bad debts, that they should be written back into that accounting period in order to ensure that the newly constituted group should commence without any bad debts.

## APPROVAL AND ADOPTION OF THE CONSTITUTION

Thanks were expressed to all involved in drawing up the constitution.

The agreed accounting year end was included and the parish was more clearly defined as the civil parish to differentiate it from the ecclesiastical parish.

With these two minor changes the constitution was adopted as proposed and signed by all present.

#### **APPOINTMENT OF CHAIRPERSON**

Keith Stacey was proposed and appointed as Chairperson.

#### **APPONTMENT OF TREASURER**

Mark Hetherington was proposed and appointed as Treasurer.

David Hudson offered to continue as a deputy treasurer, liaising with Mark on a monthly basis. It was proposed to set up a new FVG account with cheques needing two signatures from four signatories (the officers plus David Hudson). The Treasurer will create a set of financial standing orders for the group detailing powers and controls as required.

Thanks were expressed to David for his five year term as treasurer where the accounts have grown from a few hundred pounds to the sums shown in the recent accounts.

#### **APPOINTMENT OF SECRETARY**

Wendy Godfrey was proposed and appointed as Secretary.

## A.O.B.

 New bank account – Wendy will find out whether the account the choir has opened is still available and the process. (Update from WG – this account with HSBC is still available but as it comes under the business section an appointment now needs to be made at the Stafford or Hanley branch for two of the signatories to attend with required documentation. The other two signatories need only attend the Stone branch.)

- Fulfest '15 as FVG now has a formal structure it was felt that the meeting on January 6<sup>th</sup> should be focussed on establishing the management structure for Fulfest.
